

Spring 2013 Clean Up Guidelines

You must complete a 2013 Needs and Priorities Survey to Participate in any of the Spring 2013 Clean Up Opportunities

- Call the 24 Hour Logan CDNC Message Line for Reservations & Questions—487-8280
(Please do not leave email addresses or long distance phone numbers)
- To participate in individual clean up programs reservations will only be taken on dates as indicated for each type of program opportunity in the flyer. (Note these are not the actual pick up dates. Those dates will be given when your reservation is confirmed)
- Dump Passes distributed only on dates and times indicated
- Residents (includes renters) are the only persons who can call in for reservations or pick up Dump Passes.
- **DO NOT PUT OUT ITEMS TO BE PICKED UP MORE THAN 24 HOURS BEFORE YOUR ASSIGNED PICK UP DAY**
- **ITEMS MUST BE CURBSIDE NO LATER THEN 7AM ON YOUR ASSIGNED PICK UP DAY**
(Note: Curbside is considered in front of your house on the planting strip by the curb)

The City of Spokane reserves the right to refuse to haul anything considered dangerous or hazardous. Items will not be picked up from inside yards, in alleys, off porches or inside homes. If items are set out without a confirmed reservation and have to be picked up because of safety reasons the Solid Waste Department can be requested to bill your utility account of the cost of the service.



SPRING DUMP PASS PROGRAM

Dump Passes will be available **ONLY** on a first come basis to residents of the Logan Neighborhood providing the following

1. Completed Needs and Priorities Worksheet (2 pages)
 2. Photo ID with Address
 3. Avista Bill (or other document that establishes your "residency" at address)
- Landlords: Your tenants must pick up Dump Passes as they are the resident. One pass per address

If you are picking up a pass for a neighbor please bring all the items as outlined above.

DISTRIBUTION DATES: April 13th, May 11th, June 8th

DISTRIBUTION TIME: 8:30– 9:30am

DISTRIBUTION SITE: Fourth Memorial Church—2000 N Standard

(PICK UP PASSES AT STANDARD STREET ENTRANCE)

Conditions of Use are listed on the Dump Passes. Dump Passes are good for a two week period. You must pay cash or by check for anything over \$25.00 (approx. 500#) at the Waste to Energy Plant. Only one Dump Pass can be used per vehicle per trip.

Logan Neighborhood Boundaries

- Division Street from the Spokane Falls Blvd/Trent north to Euclid Avenue (3000 block north)
- Euclid Avenue from Division Street east to Napa Street (1800 block east)
- Napa Street from Euclid Avenue south to Illinois Avenue
- Illinois Avenue from Napa Street east to Crestline Street (1900 block east)
- Crestline Street from Illinois south to the Spokane River
- The Spokane River from Crestline Street to Trent west on Trent/Spokane Falls Blvd to Division Street.

****You will be called within one week after reservations close to confirm your eligibility, information left, and be given the pick up date. Do not put any items out more than 24 hours before the assigned pick up day.**
Household items must be in standard 32 gallon cans, automated carts, boxes, bags or bundles. Any receptacle other than 32 gallon cans will be considered trash and requests for replacement will not be recognized.

WEIGHT OF ANY RECEPTACLE OR ITEMS NOT TO EXCEED 80#. NO CARRY OUT SERVICE IS AVAILABLE

YOU CAN PUT OUT UP TO FOUR(4) ITEMS FROM THIS LIST (in cans, boxes, bags, bundles or automated carts) WEIGHT NOT TO EXCEED 80# EACH.

- **HOUSEHOLD TRASH**—Broken or unusable toys, housewares, clothing, tools, etc.
- **SMALL APPLIANCES**—Microwaves, toasters, etc
- **TIRES:** Maximum of 2
- **SMALL FURNITURE:** No larger or heavier than one person can carry.
- **MATTRESS & BOX SPRING**— Maximum 1 set per household

DO NOT PUT OUT- WE WILL NOT TAKE IT!

- **BLUE BIN**—recyclable items including batteries
- **LARGE APPLIANCES**— water heaters, freezers & refrigerators, stoves, air conditioners, Washers, dryers, etc.
- **CAST IRON TUBS**
- **HAZARDOUS WASTE:** oil, all paint, batteries, cleaners, pesticides, etc.
- **SOD, TREE STUMPS OR CONCRETE**
- **CLEAN GREEN**— grass clippings , branches, etc
